Add-On Modules

✓ **Exit Compliance**

- A module designed to collect designated employee's personal details, such as address, mobile number, phone number, and email ID, during their separation from the organization.
- This ensures compliance with SEBI's requirement of storing last contact details of the DPs for one year.

✓ **PIT Awareness Module**

An awareness-building module that helps employees understand compliance requirements through:

- Quiz
 - Questionnaire
 - Awareness Videos
- This module ensures employees stay informed and up to date with SEBI's PIT regulations.

✓ **Emails2SDD Automation**

- A standalone tool configured to run on the application server's Windows Task Scheduler, automating the process of converting emails into SDD (Structured Digital Database) entries.
- Reads the inbox of the UPSI Email ID configured with IMAP/Graph settings.
- Applies data mapping, business rules and logic to process the emails.
- Runs at scheduled intervals, reducing manual intervention.
- The business team can define and confirm the frequency and timing for the tool to execute seamlessly.

✓ **Employee Ledger (Benpos Comparison)**

- A comprehensive ledger system to compare employee trades with the Benpos data

to identify discrepancies, ensuring compliance with the requirement of tracking & monitoring of trades under SEBI regulations.

✓ **PIT Violation Response System**

- A dedicated response module for the employees who have executed trades that triggered a violation.
- Explain the scenario of a violation and why it occurred.
- Submit up to two responses regarding the violation.
- The submitted responses are directly emailed to the compliance team for review and further action.

✓ **Email Scheduler**

- A standalone tool that automates sending compliance related reminders with a one-time setup.
- Administrators can configure reminders for actions like Closure Window, Periodic Disclosure, Additional Disclosure, Pre-Clearance, Snapshot Scheduler, Continual Disclosure, and Exit Disclosure.
- It allows setting start dates, intervals, stop conditions, and multiple reminders ensuring timely communication and simplifying compliance tracking.

✓ *The application also offers multiple authentication methods to ensure secure access for users:*

- **System-Generated Username and Password:**
Credentials are generated and managed within the application.
- **Active Directory with LDAP:**

Seamlessly integrates with the organization's Active Directory using LDAP for centralized user authentication.

○ **Single Sign-On (SSO) with SAML:**

Provides a modern, secure, and convenient authentication method, enabling users to log in once and access multiple systems without re-entering credentials.
